



## 2018 Breakthrough Biotechnology Video Competition

### WHAT DOES "BIOTECHNOLOGY" MEAN TO YOU?

The competition is a statewide opportunity for high school students to explore how biotechnology is a part of their communities and earn a scholarship for undergraduate education in South Dakota. The competition encourages students to be creative and use videos to show how biotechnology is feeding, fueling, or healing in their community and helping to make a better world.

#### The Challenge:

1. Research and connect with 1 or more regional biotechnology companies/organizations.
2. Showcase the value of biotech in South Dakota by creating a creative 60-120s video.

#### Topics:

- A. How does Biotech Feed SD?
- B. How does Biotech Fuel SD?
- C. How does Biotech Heal SD?

#### Competition Details:

- Entries must be original works created by 9th-12th grade SD high school students
- The following Scholarship Awards will be presented (winners are responsible for the tax implications of the award):
  - First place (\$750 scholarship)
  - Second Place (\$500 scholarship)
  - Third Place (\$250 scholarship)
- Videos may be created by a single individual or team of two individuals splitting the scholarship award.
- Videos graphics, pictures, and language must be appropriate for all ages.
- Applicants retain all copyright and equivalent rights, but must provide release for SDBio, The Sanford PROMISE, HOSA, and SD EPSCoR to use the applicants' names, quotes and submissions for educational and promotional purposes, including website display and event exhibition.
- SDBio will not be held responsible for claims and complaints from third parties about published or exhibited entries.

## 2018 Breakthrough Biotechnology Video Competition

### RUBRIC

#### Does your video meet the following guidelines?

- Terms and conditions, audio/video recording release(s), and registration submitted.
- Video uploaded to YouTube (See upload instructions)
- Uploaded video is at least 60 seconds long, and no longer than 120 seconds
- Video includes title slide with unique title and "Breakthrough Biotech Video" and a slide with the participant's name(s)
- Video includes a list of credits and sources (including names of professionals or other individuals showcased in the video, website URLs, and sources for images and background research).
- All aspects of the video appropriate for an elementary audience (the video must not contain any pornographic, defamatory, illicit, illegal, or otherwise inappropriate content).
- Video does not include any copyrighted materials. For example, the wearing of clothing showing commercial logos or the display of such logos in any way in a video submission is prohibited.
- The consent and waiver of all persons featured in the video must be obtained in writing in advance and that waiver and consent must include without limitation the consent of the participant to the public posting of that person's image and must be submitted along with application. (SEE AUDIO/VIDEO RECORDING CONSENT FORM)

\*If videos do not meet the guidelines criteria, they will not be judged.

#### JUDGING CATEGORIES

##### Highlights Regional Biotech Industry (50%):

- *How well does the video and essay highlight biotechnology and its importance?* (up to 35%)
  - o Video creatively presents the meaning of biotechnology and gives strong reasons why biotechnology is important to the community.
- *At least one SD Bio member is highlighted* (up to 15%) or *at least one non-member regional Biotech organization or industry highlighted* (up to 10%)

##### Video Quality & Creativity (40%)

- *The video draws in and keeps the attention of the viewer(s)?* (up to 10%)
  - o Video gives viewer a strong understanding of biotechnology, its importance and the viewer feels like they will remember the video for a while.
- *Video is original and innovative?* (up to 10%)
  - o Video is original, creative and unique.
- *Production of video* (up to 10%)
  - o Video is well planned with smooth transitions and edits. Sound and visuals are also very good.
- *Ability to communicate science to a diverse population* (up to 10%)
  - o Language used is not too 'techy' and ideas were communicated very clearly for a community audience. (Full points).

##### Video Essays (10%)

- *Essays clearly articulate the project and experience in an engaging and authentic way.* (up to 10%)

- b. The South Dakota Biotech Breakthrough Student Video Competition Administration is comprised of SDBiotech, SD EPSCoR and Sanford PROMISE affiliates.
- c. South Dakota Biotech Breakthrough Student Video Competition Administration does not provide insurance coverage for personal injury or property damage for participants in the South Dakota Biotech Breakthrough Video Competition. Participants are not entitled to Workers Compensation benefits, or any other benefit available to employees of South Dakota Biotech Breakthrough Student Video Competition Administration.
- d. There is no guarantee that a video will be selected as a finalist or win the competition.
- e. A Participant shall be personally responsible for the payments of all expenses and costs that may be incurred as a result of her / his participation in the South Dakota Biotech Breakthrough Video Competition. Furthermore, no expenses or costs incurred by a Participant will be paid by or reimbursed by South Dakota Biotech Breakthrough Student Video Competition Administration.
- f. ## **2. Privacy**

- a. Personal information will be collected when a Participant applies for the South Dakota Biotech Breakthrough Video Competition. Registration requires that a Participant provide name, email address, birthdate and any other information deemed necessary to provide age and residency. By accepting the Terms and Conditions, a Participant grants permission and consents to South Dakota Biotech Breakthrough Student Video Competition Administration to review the Participant's videos hosted on YouTube.com, and host and/or link video for promotional purposes.
- b. The information submitted by a Participant will be used to confirm eligibility, evaluate the application, and administer awards. This information will be disclosed to the South Dakota Biotech Breakthrough Student Video Competition Administration and judges for purposes of evaluation and selection. For the public viewing portion of the competition, the Participant's name, video name and video itself will be made public.
- c. Once registered, Participants may receive periodic communications regarding to important deadlines and information. Participants will have the opportunity to opt-out of receiving this additional information.
- d. Information collected will not be sold, rented or provided to anyone for commercial or marketing purposes.
- e. Personal information received in connection with the South Dakota Biotech Breakthrough Student Video Competition may be released as required by subpoena, law or a court of competent jurisdiction. Personal information may also be disclosed as provided herein and in the event that a Participant's safety or security is at risk or in order to protect the integrity and security of the South Dakota Biotech Breakthrough Student Video Competition website.
- f. The South Dakota Biotech Breakthrough Student Video Competition Administration reserves the right to modify the privacy policy described herein at any time without prior notification to users and registrants. A notice will be posted on the websites should significant policy changes take effect.

## **3. Intellectual Property and Privacy Policies**

- b. The application and materials submitted with the application shall be considered the property of the South Dakota Biotech Breakthrough Student Video Competition upon submission and the South Dakota Biotech Breakthrough Student Video Competition shall have no obligation to return any materials to applicants.

## **4. Entire Agreement.**
